#### Article 7.07

A Union Representative is present when required on no less than **TWO HOURS** notice by the Employer

#### Article 7: UNION REPRESENTATION

**7.07:** The Union will be responsible for ensuring that there is Union Representation on shift and/or will ensure that a Union Representative is present when required on no less than two hours of notice by the Employer. The Employer will provide notice to one of the Committee Persons or Stewards on site, and if there are none, will call any number directed by the Union for such circumstances. If no Steward is available then the Employer may proceed without a Union Representative despite any express provisions in this Agreement and will notify the Union of any action taken.
